### ***Outcome of Ofsted Inspection April 2026***

I am pleased to share with you the attached Ofsted inspection report following our recent inspection on 14<sup>th</sup> and 15<sup>th</sup> April 2026, under section 5 of the Education Act 2005 (as amended).

**Pegasus Academy provides a high standard of education and care in all six of the Ofsted inspection areas with safeguarding also meeting requirements. The report praised the school as a place where pupils “succeed socially, emotionally and academically” through the support of staff who “go the extra mile”.**

Inspectors also recognised the positive progress pupils are making. The report highlights “significant improvements in examination outcomes” and says that pupils “achieve well across the breadth of the curriculum.” It also notes that pupils, including those disadvantaged, “progress well from their starting points”, “better than their peers nationally”, and that the curriculum is “well designed and carefully sequenced” to help them build knowledge and skills over time. Together, these findings provide encouraging recognition of the work pupils and staff are doing every day.

The report also reflects what we see every day in school: “Pupils enjoy coming to Pegasus Academy.” Inspectors commented positively on the atmosphere across the school, describing a calm and respectful environment where pupils “work well with their teachers and each other”, are “mature and sensible in the classroom and around the school”, and are “respectful towards each other”. The report also notes that pupils “feel safe in school and are confident in asking for help when they need it”. This reflects the high expectations staff set each day and the positive way pupils respond.

We were also pleased that inspectors recognised the academy’s clear commitment to inclusion and wellbeing. The report says that “leaders have high ambitions for all pupils” and that they “quickly identify the needs of pupils with special educational needs and/or disabilities (SEND).” Inspectors also highlighted the wider support and opportunities available to pupils, describing the personal development offer as “broad and inclusive”, praising the school’s “wide range of enrichment experiences”, and noting that “the careers programme benefits pupils significantly.” They also found that pupils are encouraged to “dream big”.

Underpinning this progress, inspectors also recognised the strength of leadership, governance and wider trust support. The report states that leaders “make decisions in the



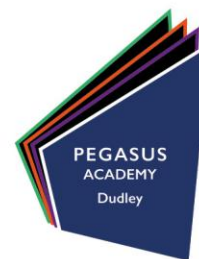

best interests of all pupils”, while “those responsible for governance have a strong understanding of the strengths and weaknesses of the school.” It also notes that staff development is “underpinned by appropriate support from the trust” and that the professional learning programme is “well-structured and responsive”. Together, these findings reflect the positive contribution Dudley Academies Trust makes to the academy’s continued improvement and to the professional development of its staff.

As per Ofsted guidance, the academy will distribute the report to all parents and carers of registered learners within five working days from the date the report was received. Ofsted usually publish the report within ten working days. The date of receipt of the report was 3<sup>rd</sup> June 2026, and we therefore expect the report to be published by Ofsted on or before 10<sup>th</sup> June. The report is also available on our school website under About Us > Statutory Information > Ofsted Report.

This outcome is a proud moment for our whole school community. It reflects the progress pupils are making, the strength of the support around them, and the shared commitment of staff, families, governors and the Trust. We are very grateful that the inspection recognised both the improvements the academy has made and the positive experience our young people are having at Pegasus Academy.
